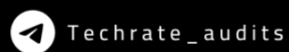

Owner privileges (In the period when the owner is not renounced)



- Owner can enable/disable swap.
- Owner can change `swapThreshold`.
- Owner can enable trading.
- Owner can switch whale tax.
- Owner can change taxes.
- Owner can change `marketingWallet`, `devWallet`, `router` and `pair` addresses.
- Owner can mark addresses as bots.
- Owner can exclude from the fees.
- Owner can change `maxTxAmount` and `maxWalletAmount`.
- Owner can manually swap and send balance to `marketing` and `dev` addresses.
- Owner can withdraw ERC20 and native tokens.
